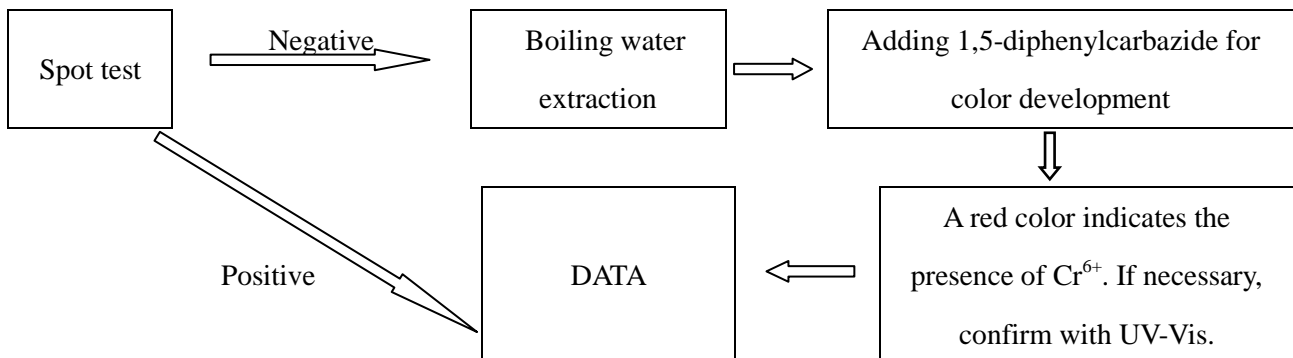


3. Test for Chromium (VI) Content
